I have undergraduate and graduate degrees in Finance from the University of Tennessee and started my career working in the banking industry. I have worked at TVA for sixteen years in our Financial Services and External Relations organizations. On the Financial Services side, I have served in several roles that have prepared me for this opportunity, including the Program Manager of Banking where I managed TVA's commercial banking relationships.

That role afforded me the opportunity to work closely with other Treasury team members to meet with potential portfolio managers for both the Nuclear Decommissioning Trust Fund, as well as the Asset Retirement Trust Fund to help ensure their long-term success. Additionally, I interacted daily with the Federal Reserve to manage ACH transactions, and I also managed three of TVA's commercial lines of credit. I worked closely with our Corporate Finance team to invest and liquidate short-term holdings to manage TVA's daily cash needs.

While all of us approach our personal investment strategy with various risk appetites, our pension system should be managed conservatively to help ensure that it will remain a stable retirement asset for current and future retirees. As we approach the target date of the pension system being fully funded in the 2030 timeframe, we should take advantage of market conditions that allow additional gains, but we should not take unnecessary risks.

On a personal note, I am passionate about investments and retirement planning and have enjoyed talking to fellow TVA employees about the retirement system and the many options available to our workforce. I have also tried to engage with folks who are early in their career to encourage them to take advantage of the many benefits working at TVA affords, especially the options available in the retirement system.

In my personal time, I have served my community in various ways, including as the treasurer of my church and as a member of the finance committee for Leadership East Tennessee.

The next several years will be a pivotal period for TVARS and the pension as we approach the milestone of it being fully funded. Likewise, for those that do not participate in the pension, TVARS must continue to offer attractive investment vehicle options to the workforce. With conservative management and keen oversight, I will help ensure the retirement system is healthy long into the future.
